# GOING HOME

- Hundreds of thousands of Syrians return after peace deal
- Trump-Putin alliance may have reversed Obama debacle

# **By Richard Walker**

ccording to a Swiss-based migration study, more than 600,000 Syrian refugees have returned to their towns, cities, and villages in the past six months. For President Donald Trump and the White House, following depressing news for the past few weeks, this is a sign that the brokered peace deal is paying off and that things are rapidly changing for the better in Syria.

The belief of so many Syrians that it is safe to go home has confirmed a trend that began slowly in the past year and has lately gained traction. The momentum and the confidence driving refugees back to Syria rather than fleeing from it would appear to confirm that Trump's military alliance with Russia's Vladimir Putin has begun to bear fruit.

There is little doubt that Russia's intervention in Syria and the military cooperation Trump has forged with the Kremlin to defeat radical groups have had a major impact on the war against terror.

In contrast, under the Obama

regime, the Pentagon and CIA fanned the flames of war by providing military support and training to Islamic militias, including the al-Nusra Front, which was also backed by Israel and Saudi Arabia. The main objective of that alliance was not the defeat of ISIS but the removal of the Syrian government. The backing of Sunni terror groups by Washington and its allies risked removing Bashar al-Assad, who was fighting ISIS, thereby placing Syria in the hands of ISIS and its coconspirators, al Qaeda.

Putin, by stepping in to support the Syrian military, put a halt to the gains of the Islamic extremist groups. That in turn set in motion the beginning of the rollback of ISIS gains in Syria.

With the arrival of Trump in the White House, the anti-ISIS military campaign was given a new lease on life as the White House ordered the U.S. military to coordinate with the Russ-

# FREE EXPRESSION IN REAL DANGER

s the editors and writers wrap up this week's issue of American Free Press, it will have been eight weeks since Wells Fargo and TSYS, the billiondollar company Wells Fargo contracts to assess financial risk, abruptly and arbitrarily canceled our credit card processing account.

We have written about this situation in detail before, but it bears repeating. For over four years, AFP had been doing business with a small credit card processor based out of Baltimore. The company was locally owned, and its customer service people were always available to help us in the event something went wrong. But six months ago, that company was bought out by Wells Fargo. After auditing the Baltimore-based company's client list, the banking behemoth decided to not only cancel AFP's account but to put us on a blacklist—known colloquially as the Match List—thereby preventing us from opening a merchant account with any credit card processor in the United States.

Since that time, this editor has personally worked with over a half-dozen companies that process credit cards. In each case so far, however, we've either been rejected in the end or the company just stopped taking my calls. In the words of one seasoned sales representative, who has been trying to help out AFP, "I've never seen anything like this before in my entire career."

To make matters worse, the recent debacle in Charlottesville has only made it harder to do business in the U.S. The federal government, banks, tech companies, and the mainstream media have all stepped up their efforts to marginalize

any conservative or politically incorrect organization or individual that questions the powersthat-be—regardless of who started the violence that day or even who was in attendance. Over the course of the past week, we've been hearing about more and more people and groups losing their credit card processing accounts, their Pay-Pal accounts, and even their website addresses—effectively driving them out of business. And

while it doesn't help the situation, we can take some comfort in the fact that AFP is not alone in this mess.

Thankfully, other organizations are fighting back like AFP is doing. Check out Dave Gahary's article on page eight in this edition on the National Rifle Association (NRA). In a series of recent videos, NRA spokeswoman Dana Loesch has been giving both barrels to the mainstream media as well as the radical left, which has been fanning the flames of hysteria in this country using fake news and hyperbole.

The problem here is that the people who support clamping down on free expression in this country don't realize they are hurting themselves as well. Free and unfettered discussion—no matter what one believes—is a sign of a healthy democratic republic. Populations and countries do change, and there could be a time in the not-so-distant future when the U.S. government becomes so empowered that there will be stiff repercussions for even minor criticisms of policies on immigration, healthcare, corruption, or personal freedom—whether they come from the right or the left.

In any event, this editor would like to take a moment to personally thank each and every subscriber who has come forward to support us. 

# News You May Have Missed

#### Good News

Four supporters of Nevada rancher Cliven Bundy have been found not guilty of numerous charges relating to their 2014 protests to stop the federal government from taking the Bundys' cattle. On Aug. 22, The Arizona Republic reported that Scott Drexler, Ricky Lovelien, Eric Parker, and Steven Stewart were found not guilty on several charges, including conspiracy, assault on a federal officer, extortion, and weapons violations. The jury was reportedly deadlocked on four charges for Parker and two against Drexler, meaning they could face a retrial. This is the second time a jury has failed to convict the men. They have been in prison since 2016.



### Trump was Right

Marxists and radical leftists are engaged in a rabid drive to tear down Confederate and white monuments nationwide. Their claim is that the boys in gray supported slavery, making all memory of them offensive to black people. President Donald Trump ridiculed the extremists, speculating their next move could be against George Washington and Thomas Jefferson because they owned slaves, and sure enough, now comes the "Rev." Al Sharpton saying Congress should defund the Jefferson Memorial in Washington, D.C. Says Sharpton: "The public should not be paying to uphold somebody who [owned slaves or supported slavery]."

### Confederate Bomber

A Houston man who's previously been convicted on explosives-related charges has been arrested after he was caught by police trying to plant explosives on a Confederate statue at a Houston park. Andrew Schneck, 25, was busted on the evening of Aug. 19 near a statue of Richard Dowling, a lieutenant in the Confederate Army. A Houston park ranger reportedly found Schneck holding two boxes with duct tape and wires as well as a bottle and a small tube containing compounds that tests later revealed were explosive materials.

# Moving in for the Kill

Two Democratic lawmakers proposed a bill to ban Confederate monuments from federal property. Reps. Adriano Espaillat (N.Y.) and Dwight Evans (Pa.) introduced the "No Federal Funding for Confederate Symbols Act." Meanwhile Rep. Corey Booker (N.J.) tweeted that he will be introducing a bill to remove Confederate statues from the U.S. Capitol Building. "We have much work to do," he tweeted.

# Trigger Warning

Cable sports television channel ESPN has pulled a college football announcer from the upcoming game between William & Mary College and the University of Virginia because the man's name is Robert Lee, and he could trigger some watchers. "We collectively made the decision with Robert to switch games as the tragic events in Charlottesville were unfolding, simply because of the coincidence of his name," said an ESPN spokesman in an official statement. "In that moment it felt right to all parties. It's a shame that this is even a topic of conversation and we regret that who calls play by play for a football game has become an issue."

# Another Trigger Warning

A group of young men and women, some of whom were wearing Trump gear, reportedly "triggered" the Howard University community over the weekend of Aug. 19-20 when they dared attempt to eat lunch in the school's cafeteria. According to online

posts and photographs, the group was accosted by university members simply because they were wearing "Make America Great" hats and t-shirts. At one time, Howard University admitted all Americans, but in the late 1970s, administrators decided to be a college for black people only.

# President's War Power Challenged

A U.S. Court of Appeals case is pending that may pose a major challenge to the ability of presidents to unilaterally launch long, drawn-out wars and could reassert the court's authority to declare a war illegal. The case, brought by Army Capt. Nathan Michael Smith, questions the legality of the U.S. war against ISIS, noting the war was never declared per the Constitution, nor was it even authorized by Congress as part of a War Powers Act Authorization for the Use of Military Force. Currently, the War Powers Act allows the use of force only for 60 days without congressional authorization, and the war against ISIS has been dragging on for three years.

### Rein in Nuke First Strike

Rep. Ted Lieu (D-Calif.) has introduced a bill—H.R.669—intended to rein in the president's ability to order a first strike of nuclear weapons. Sen. Edward J. Markey (D-Mass.) has introduced similar legislation (S. 200) in the Senate. While the bills are specifically directed against President Donald Trump, limiting any president's power to fire nuclear weapons would be a good thing.



# Fix Immigration Policy

Former presidential hopeful Darrell Castle of the Constitution Party is advocating the RAISE Act—Reforming America's Immigration for a Strong Economy. The act was proposed by Sen. Tom Cotton (R-Ark.) in February, as AFP has reported. The bill would limit chain immigration for green card holders to spouses and dependent children only, limit the number of "refugees," and eliminate the lottery. It would also raise the status of American workers by limiting immigrant competition for less-skilled jobs.

### Gunman Saves the Day

Witnesses reportedly said they saw Bobby Martin Watson, 49, attempting to rob a woman in a Publix grocery store parking lot in Seminole, Fla. recently. She struggled with the man, and he stabbed her and ran. Christopher McMann, 44, approached, only to be stabbed as well. Travis Jones, 31, then chased and tackled Watson, and was stabbed in the abdomen. Still another good Samaritan, Donald Rush, 40, grabbed a gun from his vehicle and ran at Watson and was able to take the knife and hold the culprit at gunpoint—not needing to fire—until deputies arrived.

### Secrets of Antarctica

The south polar continent is home to many secrets. Locked in or under its ice, 91 previously unknown volcanoes have recently been discovered. A research team from Scotland's University of Edinburgh used ice-penetrating radar, plus survey data from airplanes and satellites, to study 138 Antarctic volcanic peaks, most of them formerly unknown. The largest is 12,500 feet tall—comparable to the Swiss Alps. Other scientists discovered in the frozen continent one of the largest proteins ever found—used by a bacterium, Marinomonas primoryensis, to latch on to diatoms; the bacterium forms a symbiotic relationship with the microscopic alga.

ian military with only one objective: the defeat of ISIS and its cohorts.

Now, it is only a matter of time before Raqqa, the city ISIS considered the capital of its so-called caliphate, will fall. Already, ISIS is being routed across the Middle East, following its defeat in Iraq's Mosul.

Syrian refugees living in Europe and in parts of the Middle East have been closely watching the military gains against ISIS in Syria, driven by the strength of the Trump-Putin alliance. As parts of Syria have been liberated by Russian, U.S., Iranian, Turkish, and Syrian forces, Syrians are returning to reclaim their homes and businesses.

One of the striking things about the anti-ISIS alliance is that Turkey, a NATO member, has had no misgivings about working with Iranian forces in Syria. That is in stark contrast to the views being expressed on Capitol Hill that Iran is supporting terror. In fact, the Iranians have been on the front lines against ISIS, working closely with Russian and Syrian military units.

There are few in Washington who would have forecast this development at the start of 2017, but if it continues, as appears likely, the refugees returning to Syria could soon be counted in the millions.

In neighboring nations like Jordan, Lebanon, and Turkey there are at least 1 million refugees prepared to return if recent events on the ground continue to see ISIS destroyed. The fall of Raqqa, which is now a certainty, will attract the return of even larger numbers of refugees, just as the fall of Aleppo did earlier this year.



It is only a matter of time before more ISIS-controlled cities fall, allowing more refugees to go home.

While the Trump-Putin alliance yields success and unexpected good news, the migrant crisis in Europe has gotten worse. However, the flow of migrants is not from Syria, but from Libya, which became a failed state after President Barack Obama, France's Nicolas Sarkozy, and Britain's David Cameron decided to back a coup against Libyan leader Muammar Qadaffi. Evidence shows that Sarkozy wanted to remove Qadaffi in order to seize Libya's oil.

The increasing flow of Libyan migrants, assisted by a massive organized crime effort in Libya's ports, is placing Italy and Spain in jeopardy. The migrants and ISIS terrorists see both countries as a transit hub to other parts of the EU, particularly France and Germany.

On Aug. 17, Spain was hit by terrorists when radical Islamists rammed a car into pedestrians in Barcelona, killing 13 people and injuring 100. That same day, another person was killed when another vehicle slammed into pedestrians in the resort town of Cambrils, about 70 miles from Barcelona. Spanish police averted a tragedy there, though,

when they shot and killed all five suspects as they tried to flee from the car.

Following the attack, "Voice of America" reported that Spanish investigators were looking into the attackers' ties to radical Islamist groups in North Africa

"[Spanish counterterrorism officials] and their counterparts elsewhere in Europe see an emerging trend of North African links behind the recent spate of terror attacks," reported "Voice of America." ★

# A Matter of Honor: Pearl Harbor Betrayal, Blame, and a Family's Quest for Justice

n 2016—the 75th anniversary of the Pearl Harbor attack, Anthony Summers and Robbyn Swan helped unravel the mysteries of Pearl Harbor to expose the scapegoating of the admiral who was in command the day 2,000 Americans died, report on the continuing struggle to restore his lost honor—and clear President Franklin D. 

Later, to hide the biggest U.S. intelligence secret of the day, they covered it up.

Following the admiral's death, his sons—both Navy veterans—fought on to clear his name. Now that they in turn are dead, Kimmel's grandsons continue the struggle. For them, 2016 was a pivotal year.

With unprecedented access to documents, diaries, and letters, and the family's cooperation, Summers's and Swan's search for the truth has taken them far beyond the Kimmel story—to explore claims of duplicity and betrayal in high places in Washington.

A Matter of Honor is a provocative story of politics and war, of a man willing to sacrifice himself for his country only to be sacrificed himself. Revelatory and definitive, it is an invaluable contribution to our understanding of this pivotal event.

# Freedom for the Speech We Hate

• It's time to stand up for First Amendment, whether we like what's being said or not

here was a time in this country, back when the British were running things, that if you spoke your mind and it ticked off the wrong people, you'd soon find yourself in jail for offending the king of England.


Reacting to this injustice, when it was time to write the Constitution, America's founders argued for a Bill of Rights, of which the First Amendment protects the right to free speech. James Madison, the father of the Constitution, was very clear about the fact that he wrote the First Amendment to protect the minority against the majority.

What Madison meant by minority is "offensive speech."

Unfortunately, we don't honor that principle as much as we should today. In fact, we seem to be witnessing a politically correct philosophy at play, one shared by both the extreme left and the extreme right, which aims to stifle all expression that doesn't fit within their parameters of what they consider to be "acceptable" speech.

There are all kinds of labels put on such speech—it's been called politically incorrect speech, hate speech, offensive speech, and so on—but really, the message being conveyed is that you don't have a right to express yourself if certain people or groups don't like or agree with what you are saving.

Hence, we have seen the caging of free speech in recent years, through the use of so-called "free speech zones" on college campuses and at polit-

ical events, the requirement of speech permits in parks and community gatherings, and the policing of online forums.

Clearly, this elitist, monolithic mindset is at odds with everything America is supposed to stand for.

Indeed, we should be encouraging people to debate issues and air their views. Instead, by muzzling free speech, we are contributing to a growing underclass of Americans—many of whom have

been labeled racists, rednecks, and religious bigots—who are being told that they can't take part in American public life unless they "fit in."

Remember, the First Amendment acts as a steam valve. It allows people to speak their minds, assemble. air their grievances, petition for change, and contribute to a larger dialogue that hopefully results in a more just world. When there is no steam valve to release the pressure, frustration builds, anger grows, and people become more volatile and desperate to force a conversation.

The attempt to stifle certain forms of speech is where we go wrong.

The Supreme Court has held that it is "a bedrock principle underlying the First Amendment . . . that the government may not prohibit the expression of an idea simply because society finds the idea offensive or disagreeable." For example, it is not a question of whether the Confederate flag represents racism but whether banning it leads to even greater problems, namely, the loss of freedom in general.

Along with the constitutional right to peacefully (and that means non-violently) assemble, the right to free speech allows us to challenge the government through protests and demonstrations and to attempt to change the world around us—for the better or the worse—through protests and counterprotests.

As always, knowledge is key.

If ever there were a time for us to stand up for the right to speak freely, even if it's freedom for speech we hate, the time is now. ★



There are hundreds of letters and pictures, including one of the ambulances my grandmother donated (before we entered WWII), encouraged by her friend CARRIE CHAPMAN CATT, who moved around the corner from her in New Rochelle. As a youngster, I remember all the sewing machines and their many friends at my grandmother's house sewing thousands of pre-die cut clothes together to keep children warm during the brutally cold English winters.

The rear room on the first floor of Thomas Paine's house (above) in New Rochelle, N.Y. is known as the "Paine Room." On Christmas Eve 1805, a gun was fired into this room in an attempt on Paine's life. He described the incident in a letter: "Whatever the gun was charged with passed through about three or four inches below the window making a hole large enough [for] a finger to go through—the muzzle must have been very near as the place is black with powder, and the glass of the window is shattered to pieces."



In a powerful, new 53-second video ad, the NRA unleashes a blistering, withering assault on the *Times* and uses spokesperson Dana Loesch to deliver its message.

Ms. Loesch (pronounced "lash"), who was hired in June of last year to be the NRA's national spokesperson, is an award-winning journalist and television and talk-radio conservative political commentator, appearing on Fox News, CNN, CBS, ABC, and HBO among other outlets. She's intelligent, attractive, and easy to listen to, with a delivery reminiscent of the late populist patriot Jim Traficant.


In the video ad, Ms. Loesch tells the *Times*:

We the people, have had it. We've had it with your narratives, your propaganda, your fake news. We've had it with your constant protection of your Democrat overlords, your refusal to acknowledge any truth that upsets the fragile construct that you believe is real life. And we've had it with your pretentious, tone-deaf assertion that you are in any way truth- or factbased journalism. Consider this the shot across your proverbial bow. We're going to "fisk" [refute] The New York Times and find out just what "deep rich" means to this old gray hag, this untrustworthy, dishonest rag that has subsisted on the welfare of mediocrity for one, two, three, more decades. We're gonna laser-focus on your so-called honest pursuit of truth. In short, we're coming for you.

The video can be viewed online by searching for the title, "Dana Loesch: We're coming for you New York Times." It's certainly worth the watch.

Needless to say, "the ad sparked a serious backlash, with critics claiming it promotes violence," as "Fox News Insider" reported, and it led one CNN analyst to claim he "reported" the NRA for "hate speech."

An earlier NRA video ad from April of this year also raised the ire of the left. This 59-second video is quite powerful as well, and targets the Marxist factions intent on the destruction of this once-great nation.

# No Safe Space for Free Speech

# • The Virginia government's unprecedented assault on free speech

Readers will find that this AFP reporter's firsthand account of the violent protests in Charlottesville, Va. differs greatly from what Americans read about them in the controlled press and saw on mainstream TV. His report clearly shows that radical leftist groups started the attacks and that the city of Charlottesville and Virginia's state police only worked to make the situation far more dangerous for everyone there.

ug. 12 marked the auspicious and violent passing of a truly monumental milestone for red-blooded American patriots of every stripe. Driven to activism in the streets by the ever-growing cacophony of anti-white rhetoric that marginalizes and maligns Caucasians on the sheer basis of their skin color amidst numerous acts of vandalism of Confederate monuments and calls for their immediate removal, large contingents of white nationalist organizations joined ranks with hundreds of Southern heritage advocates. The venue was Lee Park—recently renamed Emancipation Park—in Charlottesville, Va. The purpose was to protest a recent decision by Mayor Michael Signer and the city council to take down a monument to Robert E. Lee that has adorned that public green and overlooked the people of that city since 1924.

As fine a tribute to the revered and celebrated Confederate general as any, even a superficial glance reveals that no expense was spared on the 26-foot-tall bronze and granite sculpture when it was commissioned by philanthropist Paul Goodloe McIntire in 1917 to immortalize the life and legacy of a man universally recognized as one of the finest generals America has ever produced.


The fact that little if anything is sacred to the left was demonstrated yet again, however, when Charlottesville Vice Mayor Wes Bellamy began agitating for the statue's removal, for Lee's name to be stricken from the memorial, and for the grounds to be renamed Emancipation Park. The city council voted in February to remove the statue, and after months of public debate voted in June to rename the park.

The backlash to the decision was swift and widespread, sparking outrage from not just Southern heritage groups like Sons of Confederate Veterans and League of the South, but on the part of many locals as well.

A great deal of activism had already been orchestrated on this front by the time Jason Kessler, a conservative blogger and president of Unity and Security for America, an organization whose stated goal is the defense of Western civilization, announced he would be organizing a "Unite the Right" rally.

The name of the rally speaks to its purpose: uniting for a day the numerous factions of the right wing to gather together in solidarity in defense of Western civilization by protesting the pending removal of the Robert E. Lee monument.

The idea quickly gained steam, and acclaim for the event reached a fever pitch on social media



in which we were briefed in considerable detail by Ike Baker, a Marine Corps vet who coordinates operational security, and Mike Tubbs, another head of security for the league. We were briefed on safety procedures that were to be followed, Virginia state laws pertaining to self-defense, the code of conduct to which all in attendance would be held, and the significance of the event in general to every traditionalist and lover of their heritage.

"We're going to Lee Park to defend Gen. Lee's statue from the godless, civilization-destroying Antifa hordes," Baker said.

They urged everyone to exercise prudence above all else and only use deadly force in their own defense if in mortal dread for their lives.

"We have to act like we are the forces of light against the darkness in a holy war," Baker continued. "We are not here to look like the savages we came out to oppose."

It was clear to all who were there that the Virginia state and local government did all they could to ensure violence occurred.

It was stated at numerous times by numerous rally organizers and participating organization leaders that the demonstration was to be a peaceful one. The plan was to march into the park, hold the line against any Black Lives Matter (BLM) and Antifa attempts to disrupt the event, listen to the speakers, and go home.

The likelihood of some violence breaking out was readily acknowledged and anticipated.

Great lengths were taken by First Amendment marchers to be prepared for whatever might come, but with the resolve that they would act only in self-defense. All attendees were encouraged to wear helmets and goggles.

The Traditionalist Workers Party procured a modest quantity of retired police riot shields. The League of the South had manufactured a number of their own. Scores of others carried bucklers and shields made from wood and emblazoned with a variety of nationalist and traditionalist heraldry. Several formally trained and certified medics had been retained to be on standby to treat any injuries.

Our group followed the plan that had been predetermined and agreed upon by security personnel, and we gathered in one of the city's large parking garages forming ranks five- to six-men wide.

The energy of the moment was positively electric. Group leaders and shield-bearers led the way with several more shield-bearers guarding the flanks of the group. But almost immediately, we

found ourselves surrounded on all sides by throngs of Antifa, BLM, and other leftists whose precise affiliations were unclear. They shrieked obscenities and insults and waved signs reading things like "Racism Destroys Communities. Get Rid of Monuments to Slavery," "Sherman Did Nothing Wrong," and "Muslims Welcome, Racists Out."

Within a few minutes of exiting the garage, several in our group were attacked by Antifa and BLM hooligans. A few scuffles broke out and four or five people in our party were hit with pepper spray, but the group pressed forward and filed into the park.

Rocks, balloons filled with bleach and pepper spray, and even bottles filled with putrid urine and

feces were thrown at us.

During this time, numerous attempts were made to breach the shield wall with pepper spray, but any holes caused in the line by these attacks were quickly plugged.

Those not in the shield wall were scattered all throughout the park waiting for the speeches to commence, and several obvious leftists aside from the many reporters for various media outlets strolled around capturing video with smart phones and talking with others in attendance.

Throughout the duration of all this pandemonium, the police presence was rather substantial, yet not a single officer could be seen making any sort of effort to keep our two groups of protestors separated.

Although the expectation for the potential of violence was very real, the general consensus had been that the previous police success at preventing anyone from getting hurt at a recent nationalist rally in Pikeville, Ky. was to be used as a template for how to keep the event at Charlottesville under control.

About 30 minutes before the speeches were scheduled to commence, a police officer began yelling through a bullhorn to the crowd, announcing that the event had been declared an unlawful assembly and all present were to disperse or be arrested.

After several minutes of this, a large number of riot police began to form up at the base of the statue of Lee in a tight shield wall and began slowly advancing toward our group. No reasons were stated for this sudden development, and if the goal in all of this was to handle a situation that was perceived to be spiraling out of control, the conduct of the police can only be described as reckless and

reactionary.

While this reporter is no expert on riot-control protocol, common sense would dictate that if a protest event is becoming too violent to manage, shoving one group of protesters into another that had been assaulting them without creating any kind of an exit for anyone to disperse or without dispersing the group blocking the exit first would be insane, not to mention a sure-fire way to recklessly endanger everyone involved. Yet this is precisely what Charlottesville's finest were doing, after having ignored the violence ensuing prior to the demand to leave.

Numerous scuffles broke out as our group was forcefully ejected from the premises. As our numbers thinned due to our members being forced out of the park, members of Antifa and BLM closed the noose tighter around us. The police seemed to be focusing all of their attention on the attendees of the rally while continuing to allow Antifa, BLM, and the rest of the leftist protestors a free hand to attack us at will.

This writer, along with a few others, narrowly squeezed past the mob as they lashed out and tried to pummel us once the police had pushed us out of the park entrance into the hostile counter-protesters.

In the confusion that followed, it was impossible to ascertain who wound up where, but that our group had been scattered around the vicinity into smaller parties was certain.

We trekked a few miles across the city and made our way to McIntire Park, the site of the so-called "free speech zone" that had been set up by the city. Our progress was slowed substantially, however, by our having to administer aid to a wounded league member who had received a rather nasty blow to the side of his head.

Shortly after arriving at this location we received word that Virginia Gov. Terry McAuliffe had declared a state of emergency, that the National Guard was being deployed, and that members of our group who had already reached McIntire Park

were being arrested by police.

It was clear at this point that no further peaceful activism was going to be conducted that day, and so the remainder of the time was spent making contact with and shuttling out of the city the rest of the rally attendees who had not yet been able to procure transportation for themselves.

That the Unite the Right rally was assaulted by leftists and violently dispersed by the police is quite clear. Yet a number of burning questions still remain:

- Why did the police not separate the two opposing groups of protestors, especially when it was known ahead of time that BLM and Antifa, who a growing number of Americans and elected officials regard as violent terrorist organizations, would be showing up to counterprotest?
- Why were the police standing down and giving violent Antifa and BLM activists a free hand to assault Unite the Right attendees at will?
- Why was nothing being done to break up the ensuing scuffles prior to the declaration that the rally was an unlawful assembly?
- If that declaration was in the interest of restoring order, why was no effort made to open up an avenue of exit through which attendees could safely evacuate without further violence?
- Why was a state of emergency declared so quickly when the police simply doing their jobs would have been more than enough to maintain order?

What is unprecedented about all of this, in this

writer's estimation, is the extent to which officialdom and the press is now in flagrant collusion with left-wing terrorists and extremists. The violent shutdown of the Unite the Right rally in Charlottesville has inaugurated a new day of infamy in American history, a day in which the left and its legions of extremists aided and abetted by the government of Charlottesville, the state of Virginia, and every major news network arrayed themselves against what was to be a peaceful protest to defend a monument.

But in a time where little more than his own white skin is sufficient to condemn a man, such heavy-handed tactics and criminal shenanigans from the left show far more potential to awaken a sleeping giant than to demoralize it to the point of submission, as was evidently hoped such a show of force would accomplish.

# Radical Vice Mayor Played Part in Instigating Violence at Rally

• Wes Bellamy openly displays appalling level of racism

r. Wes Bellamy, the controversial and outspoken vice mayor of Charlottesville, Va., who has played a leading role in efforts to remove an iconic statue of Confederate Gen. Robert E. Lee from a local city park, has a history of publishing anti-white, homophobic, and sexually degenerate messages on his social media profiles, it has been revealed.

Bellamy, originally from Atlanta, Ga., is the youngest individual ever to have been elected to the Charlottesville City Council. A vocal critic of what he regularly referred to as "white supremacists" and "bigots" who legally organized a rally recently to protest the proposed removal of the Lee monument, Bellamy moved to Charlottesville in 2009 after graduating from South Carolina State University. Bellamy worked as a community organizer and advocate for black and other "disadvantaged" youth before pursuing a career as a teacher. He received a master's degree in education in 2014 and, earlier this year, received his doctorate at Virginia State University. In 2016, Bellamy was appointed to the Commonwealth of Virginia State Board of Education before being forced to resign roughly one year later due to public outcry when his incendiary social media posts were exposed.

Late last year, Jason Kessler, a local Charlottesville activist and a leading organizer of the Unite the Right rally, which brought together various conservative, pro-Confederate South activists, white nationalists, and alt-right leaders, organizations, and groups to protest the pending removal of the Lee monument, dug up and publicized a number of Bellamy's tweets in an effort to expose the vice mayor as a hypocrite, misogynist, and bigot.

Bellamy posted a number of tweets on his personal Twitter profile containing degenerate and highly sexual statements. He also posted tweets expressing contempt and outright hatred for whites. In one tweet, Bellamy referred to white women as "devils" and in another explicitly stated that he did not like white people.

"The funniest thing about being down south is seeing little white men and the look on their faces when they have to look up to you," Bellamy condescendingly tweeted on October 13, 2012.

Following the controversy, Bellamy not only resigned from the Board of Education but was also placed on administrative leave by Albemarle County Public Schools. Bellamy had been working as a computer science teacher at Albemarle High School and was involved in a youth mentoring program and boxing club.

An unabashed radical activist, he also serves as

president of 100 Black Men of Central Virginia, advises the Collegiate 100 Black Men of Central Virginia, and serves as co-chair of the Charlottesville Alliance for Black Male Achievement.

Despite the controversy surrounding his incendiary and "politically incorrect" social media posts, Bellamy still currently serves as the vice mayor of Charlottesville and remains involved with a number of local committees and organizations, including the Charlottesville Redevelopment and Housing Authority Board and the Charlottesville Police Citizens Advisory Panel, according to his profile and biography published on the city's website.

When all of this was exposed late last year, Bellamy publicly acknowledged the tweets and apologized. "I sincerely apologize for the inappropriate things I posted to social media many years ago," Bellamy stated on his personal Facebook page. "Elected officials should be held to a higher standard, and while I was not in office at the time, in this instance I came up short of the man I aspire to be."

Bellamy has been criticized for his role in the city's response to the Unite the Right rally, which took place on Aug. 12. The rally, a legally permitted event that was upheld in a federal court after city officials attempted to illegally shut it down in the days leading up to the event, was attended by hundreds of individuals and organizations. It has been alleged that police were told to stand down as the violence escalated. When they were ordered to take action, they were told to push Unite the Right rally attendees and violent counterprotesters together, making an already volatile situation even worse.

# Gladio Meets Cointelpro in Charlottesville, Virginia

# • Why and how the Deep State silences alternative voices

merica's liberal controlled media is blaming violence in Charlottesville on the so-called alt-right. According to the dominant narrative, crazed neo-Nazi hooligans descended on a quiet college town and started beating people up and running people over. But when a violent, galvanizing, media-hyped event occurs, and the main-

stream immediately tells us who to blame, I immediately think of 9/11 and all the other false-flag outrages that have done so much damage to our country.

As I wrote in the immediate aftermath of the Charlottesville clashes:

"The recent ultraviolence in Charlottesville bears some of the hallmarks of a contrived event: It was shocking, spectacular, hyped by mainstream media, and seemingly designed to cast blame on a demonized 'other' (in this case, the alt-right white nationalist movement). Additionally, it could be seen as furthering a 'strategy of tension' pitting left against right,

multiculturalism against racial nationalism, Bernie Sanders extremists against Donald Trump extremists, and so on."

Deep-state operations designed to polarize societies pursue a "strategy of tension." They manipulate public opinion by making their opponents, whether on the left or the right, look like violent, dangerous extremists.

Operation Gladio,\* a Pentagon program run through NATO, pursued this "strategy of tension" in Cold War-era Europe. Infiltrating and manipulating both right-wing and left-wing groups, deepstate operators incited terrorism and violence, thereby discrediting opposition to NATO-bankster rule and frightening voters into supporting the establishment.

Swiss professor Daniele Ganser and other researchers have shown that virtually all of the "leftwing terrorism" in Europe during the 1960s, 1970s, and early 1980s was actually perpetrated by Operation Gladio. Likewise, most "right-wing violence" was also a Gladio product.

Could Cointelpro, a domestic U.S. equivalent of Operation Gladio, be infiltrating both white nationalist groups and their "Antifa" opposition? Undoubtedly. Could deep-state operators be fomenting violence in an effort to discredit populism? Quite possibly.

The 2016 presidential elections delivered a slap to the face of America's deep-state elite. Left-wing populist Bernie Sanders trounced Hillary Clinton in the Democratic primary and could only be kept out of the White House through election fraud. Right-wing populist Donald Trump won an overwhelming, fraud-proof victory in the Republican primaries, then defied polls and pundits by winning the general election.

Populism is surging. Elites are panicking. The



mainstream media's stranglehold over public opinion is eroding.

America's self-appointed platonic guardians are scrambling to adjust to the new reality. They appear to be resorting to ever-more-extreme measures in a desperate effort to shore up their dominance.

Their primary target is free speech on the Internet. The Trump-Sanders phenomenon was the result of 15 years of alternative media chipping away at consensus reality in general and the official story of 9/11 in particular. A deep sentiment of mistrust now pervades the populace.

The platonic guardians and the Deep State they rule are desperately seeking ways to muzzle Internet-based alternative media. During the past several months, their pet CIA search engine, Google, has been systematically tweaked in an effort to hide alternative news websites from the general public. This has resulted in a 60% decline in readership for such truth-telling websites as GlobalResearch.ca. The Deep State is also trying to cut truth-tellers' financial lifelines by such means as removing AFP's credit card processing capabilities, nuking my GoFundMe platform, orchestrating the suspension of truth-seeking academi-

cians like Professor Anthony Hall and Joy Karega from universities, banning history books from Amazon, removing alternative media from YouTube advertising programs, and otherwise trying to starve truth-seekers into submission.

But these attacks on alternative media can only

be effective to the extent that public opinion acquiesces. To overcome America's traditional affinity for free speech, as enshrined in the Bill of Rights, the Deep State needs to convince the public that the Internet is populated by dangerous, violent extremists who must be muzzled in the name of public safety and "homeland security."

And that is where events like Charlottesville come in. Observers have noted that heavily militarized police and National Guard units initially showed up in force—then conveniently disappeared just before the violence was incited.

And why were demonstrators allowed to carry weapons? Normal-

ly police prevent marchers from carrying objects that could be used as fighting implements. Yet Charlottesville demonstrators carried pepper spray, clubs, weaponizable torches, helmets, riot shields, and so on.

Finally, why does big media obsessively focus on certain self-appointed "leaders" who do everything they can to make the alt-right look bad?

Could the people who benefit the most from "populist" violence—the anti-populist elite—be up to their usual tricks?

# Yellow Journalism, White Supremacism

• Fake news media firing on all cylinders to twist what really happened in Virginia

f anyone still requires proof that the mainstream media—and the liberal political establishment—is actively setting a liberal agenda, all one needs do is look to Charlottesville. In fact, the fake news media's game plan was on vivid display for all to see—and analyze—if one took the time. What started out as a legal gathering to protest the removal of a Confederate war hero's statue, a vital and significant part of this country's history and heritage, progressed to calls to censure President Donald Trump's measured response to the violence that the corporate media whipped up.

First, the fake news media described those peacefully protesting the removal of a Robert E. Lee statue from a park in Charlottesville, Va. as "white nationalists," which was wholly inaccurate, as they had clearly never conducted any research into determining who was actually attending the rally. Then, after a car plowed into those protesting the "white nationalists," the fake news media branded the driver—and all marchers—as "white supremacists." And they stuck with that description. The "counter-protestors" were now renamed "antiracists," and the monolith that is the mainstream media used these terms exclusively.

When a Bell 407 helicopter crashed, carrying two Virginia State Police officers near Charlottesville, the fake news media upped the death toll from the rally to three, from the one killed by the car, and ran with that story from then on.

Most reports claiming "three deaths from the protest" failed to mention what *The Washington Post* has reported: that the chopper had finished surveillance of the rally "and was en route to provide air support for the motorcade of Virginia Gov. Terry McAuliffe (D) when it crashed." They also conveniently failed to mention that same helicopter had crashed in 2010, when the pilots "heard an 'unusual noise' from the engine compartment about seven minutes into the flight" and "a louder noise . . . before it lost power and crashed." Curiously, National Transportation Safety Board "[i]nvestigators could not determine why the helicopter was sent to a facility that was not authorized to do the necessary work."

Perhaps most disturbing about the way the fake—and dangerous—news media developed this story to their liking is their treatment of the president, who had the courage to say that both groups—the "white supremacists" and the "antiracists"—had blame to share. This was way too much for our media masters to swallow, and their attacks on the president have been ceaseless.

A press conference the president gave in New York on Aug. 15 starkly illustrates the craven way

the combative fake news media makes news, when ABC News reporter Mary Bruce challenged Trump, asking, "Mr. President, are you putting what you're calling the alt-left and white supremacists on the same moral plane?"

Below is the president's response and the exchange that followed, in which he handled himself masterfully:

**Trump:** I am not putting anybody on a moral plane. What I'm saying is this: You had a group on one side and you had a group on the other, and they came at each other with clubs and it was vicious. . . . But there is another side. There was a group on this side . . . you've just called them the left—that came violently attacking the other group. So you can say what you want, but that's the way it is.

**ABC News Reporter:** You said there was hatred and violence on both sides?

**Trump:** I do think there is blame—yes, I think there is blame on both sides . . . and I have no doubt about it, and you don't have any doubt about it either. And if you reported it accurately, you would say it. . . .

George Washington was a slave-owner. Was George Washington a slave-owner? So will George Washington now lose his status—are we going to take down... statues of George Washington? How about Thomas Jefferson? What do you think of Thomas Jefferson? You like him? Okay, good. Are we going to take down [his] statue because he was a major slave-owner? Now we're going to take down his statue. . . . You're changing history, you're changing culture. And you had people, and I'm not talking about the neo-nazis or the white nationalists because they should be condemned totally. But you had many people in that group other than neonazis and white nationalists, okay? And the press has treated them absolutely unfairly.

Now, in the other group also, you had some fine people, but you also had troublemakers, and you see them come with the black outfits and with the helmets and with the baseball bats. You've got a lot of bad people in the other group, too.

"You said the press has treated white nationalists unfairly," pestered another fake news media "reporter." Trump responded: "... You had a lot of people in that group that were there to innocently protest—and very legally protest—because, I don't know if you know, they had a permit; the other group didn't have a permit. ... There are two sides to a story."

# Antifa Goes to War

# • If controlled media were telling truth, they'd admit BLM, Antifa are terrorists

he radical left-wing coalition of antiracist, anti-fascist, anarchist, and communist activists and revolutionaries known collectively as "Antifa" is quickly becoming a household name in America. nered nearly 289,000 signatures as this newspaper goes to press, with the goal of having the government declare Antifa a terrorist organization.

In the wake of the highly publicized Unite the Right rally, which sought to bring together and unify the various right-wing leaders, organizations, and factions, the spotlight on Antifa is becoming more focused as its members openly and proudly call for and engage in violence against their right-wing political opponents.

The rally, organized primarily by Jason Kessler,

a local activist, blogger, and political organizer in Charlottesville, Va., generated worldwide media coverage and has served as a justification for a tyrannical, communiststyle crackdown on rightwing political dissidents and organizations by various government and law enforcement agencies, major Internet and social media companies, and online payment processors such as PayPal.

Although Kessler and other organizers of the Unite the Right rally successfully obtained a permit to hold the event, which was upheld by a

federal judge who insisted local authorities were infringing on Kessler's First Amendment rights by attempting to shut down or move the scheduled rally to an alternative location in the days leading up to the event, local and state authorities prevailed in shutting it down on the day it was scheduled to take place just prior to the rally starting.

A state of emergency was declared by Virginia's governor, and the alt-right factions who showed up at the rally were ordered to disband and leave the city, while Antifa and other leftist protesters es-



gnore the lascivious subtitle: This is a serious book about how a conquering army—even if it be one of your "allies"—treats the host population, especially its womenfolk.

How do you convince men to charge across heavily mined beaches into deadly machine-gun fire? Do you appeal to their bonds with their fellow soldiers, their patriotism, their desire to end tyranny and mass murder? Certainly, but if you're the U.S. Army in 1944, you also try another tack: You dangle the lure of beautiful French women, waiting just on the other side of the wire, ready to reward their liberators in so many ways.

That's not the picture of the Greatest

Generation that we've been given, but it's the one Roberts paints to devastating effect in What Soldiers Do. Drawing on an incredible range of sources, including news reports, propaganda and training materials, official planning documents, wartime diaries, and memoirs, Roberts tells the fascinating and troubling story of how the U.S. military command systematically spread—and then exploited the myth of French women as sexually experienced and available. The resulting chaos—ranging from flagrant public acts with prostitutes to outright rape and rampant venereal disease—horrified the war-weary and demoralized French population. The sexual predation, and the blithe response of the American military leadership, also caused serious friction be-



tween the two nations just as they were attempting to settle questions of control over the liberated territories and the restoration of French sovereignty.

While never denying the achievement of D-Day, or the bravery of the soldiers who took part, What Soldiers Do reminds us that history is always more useful and more interesting—when it is most honest, and when it goes beyond the burnished beauty of nostalgia to grapple with the real lives and real mistakes of the people who lived it.

sentially took over the streets and violently confronted the right-wing rally attendees who were trying to obey police orders to leave. Countless fights and other scuffles broke out in Charlottesville as a direct result of the actions taken by local and state political and law enforcement authorities.

The overall media narrative emanating from Charlottesville was and largely remains that the right-wing factions who organized and attended the rally engaged in violence and terrorism against the Antifa and leftist protesters, an absurd narrative that is almost the exact opposite of what truly transpired that day. (See pages 10-12 of this issue.)

The New York Times, one of the most establishment-serving fake news outlets in the country, interviewed a number of prominent Antifa organizers and activists in the wake of the rally, and many of them openly boasted of their intent to continue to violently confront "racists" and "white supremacists" in an effort to advance their political objectives. Antifa members argue that the burgeoning alt-right and conservative populist movements, which they view as being fueled and endorsed by the Trump administration, need to be physically confronted.

"People are starting to understand that neo-nazis don't care if you're quiet, you're peaceful," Emily Rose Nauert, a delusional young Antifa member based in California, explained to the Times. "You need violence in order to protect nonviolence. That's what's very obviously necessary right now. It's fullon war, basically."

Other Antifa activists interviewed in the article bizarrely contended that even allowing right-wing activists to organize and hold rallies and public events amounts to a form of violence that requires equally violent countermeasures.

"When you look at this grave and dangerous threat—and the violence it has already caused is it more dangerous to do nothing and tolerate it, or should we confront it?" Frank Sabate, yet another fanatical Antifa activist, asked the *Times* rhetorically. "Their existence itself is violent and dangerous, so I don't think using force or violence to oppose them is unethical."

Some Antifa members said they would be willing to escalate the violence into all-out shootouts.

"I hope we never get there," 29-year-old Antifa anarchist "Tony Hooligan" told the Times. "But we are willing to get there."

Suffice it to say, Antifa members and their fakenews media enablers, along with major globalists who fund their operations, such as the plutocratic, nation-wrecking billionaire George Soros, are entirely disconnected from reality. It is Trump supporters and other right-wingers who are being violently confronted and attacked by the left—not the other way around.





# Destroying Monuments Solves Nothing

• Like the Taliban in the Mideast, culture destroyers trying to erase history in America


hey had found a leader, Robert E. Lee—and what a leader! . . . No military leader since Napoleon has aroused such enthusiastic devotion among troops as did Lee when he reviewed them on his horse Traveller." So wrote Samuel Eliot Morison in his magisterial The Oxford History of the American People in 1965.

First in his class at West Point, hero of the Mexican War, Lee was the man to whom President Lincoln turned to lead his army. But when Virginia seceded, Lee would not lift up his sword against his own people, and chose to defend his home state rather than wage war upon her.

This veneration of Lee, wrote Richard Weaver, "appears in the saying attributed to a Confederate soldier, 'The rest of us may have . . . descended from monkeys, but it took a God to make Marse Robert."

Growing up after World War II, this was accepted history. Yet, on the militant left today, the name Lee evokes raw hatred and howls of "racist and traitor." A clamor has arisen to have all statues of him and all Confederate soldiers and statesmen pulled down from their pedestals and put in museums or tossed onto trash piles.

What has changed since 1965? It is not history. There have been no great new discoveries about Lee. What has changed is America herself. She is not the same country. We have passed through a

great social, cultural, and moral revolution that has left us irretrievably divided on separate shores. And the politicians are in panic.

Two years ago, Virginia Gov. Terry McAuliffe called the giant statues of Lee and "Stonewall" Jackson on Richmond's Monument Avenue "parts of our heritage." After Charlottesville, New York-born-andbred McAuliffe, entertaining higher ambitions, went full scalawag, demanding the statues be pulled down as "flashpoints for hatred, division, and violence."

Who hates the statues, Terry? Who's going to cause the violence? Answer: The Democratic left whom Terry must now appease. McAuliffe is echoed by Lt. Gov. Ralph Northam, the Democratic candidate in November to succeed McAuliffe. GOP nominee Ed Gillespie wants Monument Avenue left alone. The election is the place to decide this, but the left will not wait.

In Durham, N.C., our Taliban smashed the statue of a Confederate soldier. Near the entrance of Duke University Chapel, a statue of Lee has been defaced, the nose broken off.

Wednesday at dawn, Baltimore carried out a cultural cleansing by taking down statues of Lee and Maryland Chief Justice Roger Taney who wrote the Dred Scott decision and opposed Lincoln's suspension of the right of habeas corpus. Like ISIS, which smashed the storied ruins of Palmyra, and the al Qaeda rebels who ravaged the fabled Saharan city of Timbuktu, the new barbarism has come to America. This is going to become a blazing issue, not only between but within the parties.

For there are 10 Confederates in Statuary Hall in the Capitol, among them Lee, Georgia's Alexander Stephens, vice president to Jefferson Davis, and



Davis himself. The Black Caucus wants them gone. Mount Rushmore-sized carvings of Lee, Jackson, and Davis are on Stone Mountain, Ga. Are they to be blasted off?

There are countless universities, colleges, and high schools like Washington & Lee named for Confederate statesmen and soldiers. Across the Potomac from D.C. are Jefferson Davis Highway and Leesburg Pike to Leesburg itself, 25 miles north. Are all highways, streets, towns, and counties named for Confederates to be renamed? What about Fort Bragg?

On every Civil War battlefield, there are monuments to the Southern fallen. Gettysburg has hundreds of memorials, statues and markers. But if, as the left insists we accept, the Confederates were traitors trying to tear America apart to preserve an evil system, upon what ground do Democrats stand to resist the radical left's demands?

What do we do with those battlefields where Confederates were victorious: Bull Run, Fredericksburg, Chancellorsville? "Where does this all end?" President Donald Trump asked.

# Erasing Dissenting Opinions

• World's biggest tech companies collude to control freedom of speech

ome of the world's top technology and social media companies have increased their already full-scale assault on conservative and other right-wing political dissidents and organizations in the wake of the Unite the Right rally in Charlottesville, Va., which took place two weeks ago. The event was organized and promoted by some of the leading figures in the conservative, alt-right, and white nationalist communities, and became the scene of mob violence and mayhem that shocked the country.

The event, designed to protest the removal of a statue commemorating Confederate Gen. Robert E. Lee as well as to unite the various factions of the flourishing and increasingly popular alt-right movement, was organized largely by Jason Kessler, a local activist, blogger, and community organizer in Charlottesville. Kessler and his supporters obtained a legal permit to hold the rally, overcoming numerous obstacles placed in their way by local political leaders, including the mayor of Charlottesville and its city council.


Unfortunately, the rally was a total disaster for Kessler and other participants of the Unite the Right rally, as Virginia Gov. Terry McAuliffe declared a state of emergency and local and state law enforcement officials shut down the event. Then, Unite the Right attendees were forced by law enforcement officials into the throngs of counter-protesters to ensure a violent confrontation would take place. This was obviously orchestrated by Virginia officials.

The narrative of the event emanating from the fake news media portrayed the organizers and attendees of the Unite the Right rally as violent, unhinged white supremacists, racists, Klansmen, and neo-nazis who were responsible for the violence and mayhem in Charlottesville. Leading leftist activist organizations, including the Southern Poverty Law Center and Anti-Defamation League, media pundits across the country, and virtually the entire political establishment condemned the alt-right, blaming its adherents and activists as the instigators and initiators of the violent melee.

Nothing could be further from the truth, as this newspaper has expertly detailed in this week's edition

The Unite the Right rally drew international attention and remains the focus of much media coverage. Major social media and other high-tech companies centered in Silicon Valley began targeting many of the most prominent alt-right activists and organizations in the wake of the event, banning them from their services, forcing them offline, and removing them from Internet search results.

Andrew Anglin, publisher of the highly contro-



versial Daily Stormer—one of the top far-right websites in the world—has essentially been forced off the Internet, as the domain for his website was seized from him by GoDaddy, a leading website registration company.

As AFP goes to press, Anglin has successfully set up a new domain for the Daily Stormer, www.punishedstormer.com. It remains unclear if the site will stay online.

Leading figures in the alt-right, including Richard Spencer and Jared Taylor, have been censored by a variety of social media and tech companies. Numerous individuals associated with the alt-right have been banned from Twitter, Facebook, and YouTube and have had their PayPal accounts permanently limited.

"Doofuses say it's only censorship if the government does it," Richard Spencer recently explained. "YouTube and Twitter and Facebook have more power than the government. If you can't host a website or tweet, then you effectively don't have a right to free speech."

Spencer went on to argue that "social networks need to be regulated in the way the broadcast networks are." The top tech companies dominating the Internet and social media—Twitter, Facebook, and Google, for example—should be viewed as public utilities, Spencer contends. "We should start conceiving of these things as utilities and not in terms of private companies." he stated.

Not all tech companies are caving, though. Gab.ai, an alternative to Twitter, has become increasingly more popular as right-wing dissidents are forced off of Twitter, Facebook, and other social media outlets. Gab.ai is a staunch supporter of free speech, at least for the time being. Other tech companies have also been launched in recent years in the wake of leftist censorship of right-wing dissidents.

As readers of this newspaper know full well, political dissidents and publications challenging the fake news media and its leftist, anti-white narratives have been facing enormous challenges operating and publishing on the Internet.

The assault on the First Amendment rights of those of us opposing political correctness, speaking and publishing openly and frankly about some of the most controversial issues facing our world, and challenging commonly accepted historical and contemporary narratives promoted by the fake news media and political establishment could not be more obvious.

The very concept of free speech, free historical and intellectual inquiry, and the First Amendment remain in limbo in the aftermath of the Unite the Right rally in Charlottesville.

The tyrannical, communist-style crackdown on any form of right-wing political dissident could not be more evident. ★

# • Liberty survivor Tourney, disabled vet Gahary given award

ALLAS, Texas—The Military Order of the Purple Heart (MOPH) national convention took place in "Big D" from Aug. 12-18, and American Free Press was in attendance. In fact, this writer and USS *Liberty* survivor Phil Tourney were invited to the 85th annual meeting to make a presentation to the veterans about the USS *Liberty* Film Project both men are promoting.

The significance of speaking to such a large group cannot be overstated. Never before in the more than 50 years since the massacre of 34 and wounding of 174 Americans on the high seas in international waters by the Zionist state of Israel has the story of the *Liberty* been allowed to be told to such a mainstream audience. Prior to this, this newspaper's precursor, *The Spotlight*, was the only entity to draw as much attention to the *Liberty* massacre.

The congressionally chartered MOPH has over 45,000 members, who have received the Purple Heart award while serving in the U.S. armed forces.

Significantly, in order to be eligible for membership in the MOPH, an individual must be "of good moral character" and have "received the Purple Heart for wounds . . . against an armed enemy of the United States." The men aboard the *Liberty* on the day of the massacre, June 8, 1967, received 208 Purple Hearts, clearly placing Israel in the "enemy" camp.

Those present during the Liberty presenta-

tion—around 300—listened attentively and gave a standing ovation, as well as heartily supporting the movie project, an attempt to get the story of the massacre on video, via a full-length feature film, to finally mass-educate the world about the most decorated ship in U.S. Navy history for a single engagement.

This reporter and his partner in the project received a plaque from the MOPH in recognition for the work we have done for veterans, quite an honor, we both agreed. It read, in part, "In appreciation of your commitment and continuous support of veterans."

Besides being afforded the great opportunity to speak in front of the MOPH, a presentation was offered in front of the Ladies Auxiliary of the MOPH (LAMOPH), the MOPH's sister organization, consisting of "mothers, wives, sisters, widows, daughters, stepdaughters, granddaughters and legally adopted female lineal descendants of Purple Heart recipients, who may or may not be MOPH members themselves." Although it is a wholly separate organization from the MOPH, LAMOPH shares the same goals and mission, and fully supported the movie project, as well as making a separate contribution to the upcoming film.

One of those present at the MOPH convention was Purple Heart recipient Walter P. Kaczmarek Jr., who was one of only three U.S. Marines to raise the American flag over Hué City in Vietnam at the capital building, when they liberated the city during the Battle of Hué, one of the bloodiest and longest battles of the Vietnam War, lasting from Jan. 30, 1968, until March 3, 1968. The significance of the battle is memorialized in a U.S. Navy ship, USS *Hué City*, the only U.S. Navy ship

named after a battle in the Vietnam War.

Walter discussed the MOPH organization. "It's pretty exclusive," he began. "The only organization more exclusive is the Medal of Honor society."

The Medal of Honor (MOH), the oldest continuously issued combat decoration of the U.S. Armed Forces, is the country's highest and most prestigious military decoration, awarded by the president. The *Liberty*'s skipper, William McGonagle, had his MOH presented to him in secret at the Washington Navy Yard by the secretary of the Navy, the only time—before or since—an MOH recipient was awarded in this manner.


Walter then discussed the *Liberty* presentation. "They [the Navy MOPH members present in the audience] were riveted to your speech, your talk," he said. "Sure enough, you got a standing ovation. They were very impressed. A lot of men in that room were hearing about the *Liberty* for the first time."

"It's been one of the most rewarding experiences of my life, to be around men, great heroes, who gave their blood and their limbs for this country," added Tourney.

# Bankers, Generals Surround Trump

• Is president's populist-nationalist, America-first policy in danger of being eclipsed?

have not become the king's first minister in order to preside over the liquidation of the British empire," said Winston Churchill to cheers at the Lord Mayor's luncheon in London in November 1942. True to his word, Churchill did not begin the liquidation.

When his countrymen threw him out in July 1945, that role fell to Clement Attlee, who began the liquidation. Churchill, during his second premiership from 1951-1955, would continue the process, as would his successor, Harold Macmillan, until the greatest empire the world had ever seen had van-

While its demise was inevitable, the death of the empire was hastened and made more humiliating by the wars into which Churchill had helped to plunge Britain, wars that bled and bankrupted his nation. At Yalta in 1945, Stalin and FDR treated the old imperialist with something approaching bemused contempt.

War is the health of the state, but the death of empires. The German, Austro-Hungarian, Russian, and Ottoman empires all fell in World War I. World War II ended the Japanese and Italian empires—with the British and French following soon after. The Soviet empire collapsed in 1989. Afghanistan delivered the coup de grace. Is it now the turn of the Americans?

Like presidents Obama and Bush, he does not in-

tend to preside over a U.S. defeat in its longest war. Nor do his generals. Yet how can we defeat the Taliban with 13,000 troops when we failed to do so with the 100,000 Obama sent?

The new troops are to train the Afghan army to take over the war, to continue eradicating the terrorist elements like ISIS, and to prevent Kabul and other cities from falling to a Taliban now dominant in 40% of the country.

Yet what did the great general, whom Trump so admires, Douglas MacArthur, say of such a strategy? "War's very object is victory, not prolonged indecision." Is not "prolonged indecision" what the Trump strategy promises? Is not "prolonged indecision" what the war policies of Obama and Bush produced in the last 17 years?

Understandably, Americans feel they cannot walk away from this war. For there is the certainty as to what will follow when we leave.

When the British left Delhi in 1947, millions of former subjects died during the partition of the territory into Pakistan and India and the mutual slaughter of Muslims and Hindus.

When the French departed Algeria in 1962, the "Harkis" they left behind paid the price of being loyal to the mother country.

When we abandoned our allies in South Vietnam,



Can we expect three generals and a Wall Street insider to carry out the president's America-first agenda when it comes to war and finance?

the result was mass murder in the streets, concentration camps, and hundreds of thousands of boat people in the South China Sea, a final resting place for many. In Cambodia, it was a holocaust.

Trump, however, was elected to end America's involvement in Middle East wars. And if he has been persuaded that he simply cannot liquidate these wars—Libya, Syria, Iraq, Yemen, Afghanistan—he will likely end up sacrificing his presidency, trying to rescue the failures of those who worked hardest to keep him out of the White House.

Consider the wars, active and potential, Trump faces. Writes Bob Merry in the fall issue of *The National Interest*: "War between Russia and the West seems nearly inevitable. No self-respecting nation facing inexorable encirclement by an alliance of hostile neighbors can allow such pressures and forces to continue indefinitely. Eventually (Russia) must protect its interests through military action."

If Pyongyang tests another atom bomb or ICBM,

some national security aides to Trump are not ruling out preventive war. Trump himself seems hellbent on tearing up the nuclear deal with Iran. This would lead inexorably to a U.S. ultimatum, where Iran would be expected to back down or face a war that would set the Persian Gulf ablaze. Yet U.S. voters did not cast ballots for confrontation or war.


America voted for Trump's promise to improve ties with Russia, to make Europe shoulder more of the cost of its defense, to annihilate ISIS and extricate us from Mideast wars, to stay out of future wars. America voted for economic nationalism and an end to the mammoth trade deficits with the NAF-TA nations, EU, Japan, and China. America voted to halt the invasion across our southern border and to reduce legal immigration to ease the downward pressure on American wages and the competition for working-class jobs.

Yet today we hear talk of upping and extending the U.S. troop presence in Afghanistan, Iraq, and Syria, of confronting Iran, of sending anti-tank and antiaircraft weapons to Ukraine to battle pro-Russia rebels in the east.

Can the new custodians of Trump's populist-nationalist and America-first agenda—the generals and the Goldman Sachs alumni association—be entrusted to carry it out? ★

# Make War on Venezuela?

here is something unsettling about how President Donald Trump has surrounded himself with generals. From his defense secretary to his national security advisor to his White House chief of staff, Trump looks to senior military officers to fill key positions that have been customarily filled by civilians. He's surrounded by generals and threatens war at the drop of a hat.

Trump began last week by threatening "fire and fury" on North Korea. He continued through the week claiming, falsely, that Iran is violating the terms of the nuclear deal. He finally ended the week by threatening a U.S. military attack on Venezuela.

He told reporters on Friday that, "We have many options for Venezuela including a possible military option, if necessary. . . . We have troops all over the world in places that are very, very far away. Venezuela is not very far away, and the people are suffering, and they are dying.

Venezuela's defense minister called Trump's threat "an act of craziness."

Even more worrisome, when Venezuelan President Nicolas Maduro tried to call Trump for clarification he was refused. The White House stated that discussions with the Venezuelan president could only take place once democracy was restored in the country. Does that mean Trump is moving toward declaring Maduro no longer the legitimate president of Venezuela? Is Trump taking a page from Obama's failed regime-change policy for Syria and declaring that "Maduro must go"?

The current unrest in Venezuela is related to the

economic shortcomings of that country's centrally planned economy. The 20th century has shown us very clearly that state control over an economy leads to mismanagement, mal-investment, massive shortages, and, finally, economic collapse. That is why those of us who advocate free-market economics constantly warn that U.S. government intervention in our own economy is leading us toward a similar financial crisis.

But there is another factor in the unrest in Venezuela. For many years the U.S. government, through the CIA, the National Endowment for Democracy, and U.S. government-funded nongovernmental organizations, has been trying to overthrow the Venezuelan government. They almost succeeded in 2002, when then-president Hugo Chavez was briefly driven from office. Washington has spent millions trying to manipulate Venezuela's elections and overturn the results. U.S. policy is to create unrest and then use that unrest as a pretext for U.S. intervention.

Military officers play an important role in defending the United States. Their job is to fight and win wars. But the White House is becoming the war



house and the president seems to see war as a first solution rather than a last resort. His threats of military action against a Venezuela that neither threatens nor could threaten the United States suggest a shocking lack of judgment.

Congress should take Trump's threats seriously. In the 1980s, when President Ronald Reagan was determined to overthrow the Nicaraguan government using a proxy army, Congress passed a series of amendments, named after their author, Rep. Edward Boland (D-Mass.), to prohibit the president from using funds it appropriated to do so.

Congress should make it clear in a similar manner that, absent a Venezuelan attack on the United States, Trump would be committing a serious crime in ignoring the Constitution were he to follow through with his threats.

Maybe they should call it the "We're Not the World's Policeman" act.




# Trump Indicates He'll Pardon Arpaio

resident Donald Trump recently announced that he is considering pardoning former Sheriff Joe Arpaio, which would repudiate the guilty verdict handed down by federal Judge Susan Bolton in a non-jury trial that wrapped up July 6. It would not only cancel the sentencing of "America's sheriff" that's scheduled for Oct. 5. It also would very likely set off yet another media-induced firestorm, accusing Trump of being so beyond the pale in the view of the powers that be that even louder but misguided calls for his removal from office will be heard.

Arpaio, who's 85, was found guilty of misdemeanor criminal contempt for defying a 2011 court order to stop patrols that targeted suspected illegal immigrants. He detained those who were here illegally and handed them over to federal custody.

In his final years of his 24-year tenure as Maricopa County sheriff, in a border state often nearly overrun by illegal immigrants, Arpaio emerged as a leading opponent for stopping illegal immigration. Thus he became someone the Barack Obama administration, the media, and the left still view



with utter contempt.

Trump clarified his outlook on Aug. 13 during an interview with Fox News at his Bedminster, N.J. golf club. "I am seriously considering a pardon for Sheriff Arpaio," said Trump. "He has done a lot in the fight against illegal immigration. He's a great Amer-

ican patriot, and I hate to see [this happen]to him."

Mark Goldman, one of Arpaio's attorneys, told AFP on Aug. 16 that it's hard to say for sure if and when Arpaio, a former federal Drug Enforcement Administration officer, may be pardoned.

Trump has not granted any pardons so far in his presidency. Given the nation's hyper-sensitive atmosphere currently, Goldman declined to comment at length, adding that Arpaio is not yet at liberty to comment.

Goldman did tell AFP, though: "If Joe is pardoned, he'll accept it. He has great respect for the president, and he hasn't requested anything."

Mindful that Arpaio could get six months behind bars if he's sentenced in October, Goldman shared copies of two motions just filed in the U.S. District Court in Phoenix. One requests a new trial by jury and/or to vacate the judgment; the other seeks a judgment of acquittal.

However, Trump revisited the matter during his fiery speech in Phoenix, Ariz. on Aug. 22.

"Was Sheriff Joe convicted for doing his job?" he asked the people in the audience to raucous applause, before adding that "he's going to be just fine, okay?"

Alluding to the pardon, Trump said, "I won't do it tonight because I don't want to cause any controversy. But Sheriff Joe should feel good." ★



# Inside the Poison Papers

• Documents reveal decades of government cover-ups on toxic chemical dumps

arol Van Strum desired a simple life when she and her family moved to Oregon's idyllic Siuslaw National Forest in 1974. Little did she know that she would become a curator of information indicting powerful chemical companies and government agencies, which resulted in the creation of an online library known as the "Poison Papers," or that she would suffer personal tragedy as well.

Published by the Center for Media and Democracy and the Bioscience Resource Project, the Poison Papers lay out "a 40-year history of deceit and collusion involving the chemical industry and the regulatory agencies that were supposed to be protecting human health and the environment," according to Peter von Stackelberg, a journalist who helped establish the online collection, as reported by Sharon Lerner on the news website "TheIntercept.com."

The saga began in the 1970s when Ms. Van Strum asked U.S. Forest Service employees to stop spraying herbicides in the area of her home. In one incident, her children had been directly doused as they fished in a nearby river.

Ms. Lerner reported: "Immediately after they were sprayed, Van Strum's children developed nosebleeds, bloody diarrhea, and headaches, and many of their neighbors fell sick, too. Several women who lived in the area had miscarriages shortly after incidents of spraying. Locals described finding animals that had died or had bizarre deformities—ducks with backward-facing feet, birds with misshapen beaks, and blinded elk; cats and dogs that had been exposed began bleeding from their eyes and ears. At a community meeting, residents decided to write to the Forest Service detailing the effects of the spraying they had witnessed."

Ms. Van Strum thought, as any reasonable American would, once the agency knew how detrimental the spraying was "they wouldn't do it anymore."

She discovered that the herbicide used by the Forest Service contained an active ingredient used in Agent Orange, which even the U.S. military stopped using in Vietnam after it became known it caused serious harm to humans and the environment. Ms. Lerner reported that "between 1972 and 1977, the Forest Service sprayed 20,000 pounds of 2,4,5-T (an active ingredient in Agent Orange) in the 1,600-square-mile area that included Van Strum's house and the nearby town of Alsea."

The Forest Service refused Ms. Van Strum's request, so she, along with her neighbors, took them to court, which resulted in a victory of sorts. A tem-



porary ban was issued on the use of 2,4,5-T in 1977, and it was ultimately stopped in 1983, according to Ms. Lerner.

"We didn't think of ourselves as environmentalists; that wasn't even a word back then. We just didn't want to be poisoned," Ms. Van Strum said.

Tragically, Ms. Van Strum's four children died in a 1997 home fire, which spread suspiciously quickly and was not investigated. Ms. Lerner reported: "Firefighters who came to the scene said the fact that the whole house had burned so quickly pointed to the possibility of arson. But an investigation of the causes of the fire was never completed."

Today, Ms. Van Strum lives in an outbuilding next to the cleared area where her home once stood and has accepted the fact she will "never really know" whether foul play was involved.

Jonathan Latham, Ph.D., cofounder and director of the Bioscience Resource Project and director of the Poison Papers, explains how things got to the point where bureaucratic agencies, such as the Environmental Protection Agency (EPA), don't care about the public they are charged with protecting.

When agency scientists discover wrongdoing, such as fraud by major chemical companies, they "don't do anything about it because they have to pass it up the line" to their senior administrator (and ultimately) to the president, who will have to take a stand against a toxic chemical and its producer,

Dr. Latham told Todd Zwillich on WNCY radio on July 31.

Latham said bad news doesn't travel up the agency, leaving a "closet full of skeletons," which aptly describes the Poison Papers.

For instance, a company called Industrial Bio-Test Laboratories (IBT) was responsible for up to 40% of all chemical safety tests.

Monsanto and other giants used this testing company, which got some media attention in light of a negative report issued by the Food and Drug Administration. Top bureaucrats had to "do something."

Rebekah Wilce reported on "independents-ciencenews.com" that testing animals would decompose so quickly that "their bodies oozed through wire cage bottoms and lay in purple puddles on the dropping trays" and that IBT invented an acronym "TBD," later discovered to mean "too badly decomposed."

Poison Papers documents reveal a secret meeting with the EPA, Canada's Health Protection Branch, and top chemical companies on Oct. 3, 1978 at the Howard Johnson Motor Inn in Arlington, Va.

Government bureaucrats "kicked the can down the road," giving IBT a chance to resubmit studies, according to Latham. He noted that, "Meanwhile, you're not telling the public that the chemicals that they're using in their households and yards and that are in their food have unsound tests behind them. . . . In some cases, 100% of the tests were unsound."

Those who wonder what is causing so much illness, such as cancer, dementia, and other problems, may have an answer, and it lies in chemical exposure, said Latham.

The evidence continues to mount daily against big business and government.

If the words of those who poison and the bureaucrats who cover up and do nothing won't convince us we need to take action, what will?

# Famed Black Nationalist, Comedian Passes

ick Gregory, author, political activist, comedian, and longtime friend to American Free Press, died Aug. 21 in Washington, D.C. He was 84 and is believed to have died from complications of heart disease.

Born in St. Louis on Oct. 12, 1932, Gregory became one of the earliest black standup comedians in the 1950s, while in the military. Before long he was appearing at the Playboy Club and on late-night television and made it to 82nd place in Comedy Central's list of "The 100 Greatest Stand-ups of All Time."

A noted activist, Gregory marched with Martin Luther King Jr. and Malcolm X. In 1967 he ran for mayor of Chicago and in 1968 for president in the Freedom and Peace Party. During the 1980 Iranian hostage crisis he went to Tehran to try to negotiate the hostages' release and engaged in a public hunger strike.

Reports on Gregory's death were published around the world, but what the establishment obituaries of this man fail to mention is that Gregory was wise to 9/11. In his own words, he said, "The way the twin towers and Building 7 fell just didn't make any sense."

Gregory began researching the anomalies that disprove the official conspiracy theory of the crimes of Sept. 11, 2001. But not until many years later did he become aware of a group of professional men who could confirm his suspicions. On Sept. 9, 2010, at a press conference held by the Architects & Engineers for 9/11 Truth group (AE911Truth), he listened as a case was laid out for controlled demolition. Gregory was so impressed he announced he would embark on a two-year solid food fast for 9/11 truth.

He believed the technical focus AE911Truth has maintained will enable it to withstand hostile

scrutiny from professionals.

"The difference here is that mathematics is the same throughout the world," he said. "When architects and engineers see your research, it will make sense to them. Now those who feel inspired to share the truth with others will have talking points that are backed by hard science and expert analysis."

Gregory once told AMERICAN FREE PRESS, "9/11 is a trick. The numbers 9-1-1 [the phone number for emergencies] tell your brain to be scared."

In an interview with Victor Thorn, Gregory said: "I don't get my news from NBC anymore. Instead, I look for rips in the fabric. That's why I knew Obama would be president 10 years ago. Obama's father and mother were both CIA. Everyone that messes with him dies. I know all about that crooked guy."

If you have not previously studied the evidence that the government and mass media are lying about the events of 9/11, now would be a good time to honor the memory of Gregory by doing so. ★

# Man of Exceptional Caliber

Robert Edward Lee was a man of exceptional caliber, and the best soldier on either side during the Civil War. Through his intrepid and clever leadership, the Army of Northern Virginia repeatedly defeated Union Army contingents two and three times its size.

Graduating second in his class at West Point Military Academy, Lee never received a single demerit while a cadet there.


